AN ORDER OF THE COUNTY COMMISSION OF FAYETTE COUNTY, WEST VIRGINIA, SITTING AS A BOARD OF CANVASSERS TO CANVASS THE RESULTS OF A SPECIAL ELECTION HELD ON SEPTEMBER 8, 1978, IN FAYETTE COUNTY, WEST VIRGINIA FOR THE PURPOSE OF INCORPORATION OF THE TERRITORY OF GAULEY BRIDGE, FAYETTE COUNTY, WEST VIRGINIA TO CLASS IV TOWN OR VILLAGE.

On this 14th day of September, 1978, at a Special meeting of said County Commission, a special call having been issued for the purpose of canvassing the returns of a special election held in Fayette County, West Virginia, for the purpose of Incorporation of the Territory of Gauley Bridge, Fayette County, West Virginia, to Class IV Town or Village, the County Commission of Fayette County, West Virginia sitting as a Board of Canvassers in accordance with law, proceeded to canvass the returns of said special election. Said ballots were then again sealed up in a new envelope and each member of the Canvassing Board wrote his name across the place where said envelop was sealed.


After which, the Board carefully and impartially examined the returns of said special election and having ascertained the results of the votes cast therein, doth hereby record the same in the following form, to-wit:



The Commission meeting in Regular Session this date, was called to order by the President, Charles M. Vickers.

Mr. Sam Ferris, from the Oak Hill Social Security Office, appeared before the Commission requesting permission for use of the Danese Building for hearings one day per month. He was advised by the Commission to look over the building to determine if it would be desirable and report back to them.

Donald McCallister, Gauley Bridge, came before the Commission in regard to obtaining information from the Assessor. Since the Assessor is an elected official Mr. McCallister was informed there was nothing the Commission could do in the matter.

Paul Blake, Attorney, Fayetteville, appeared before the Commission concerning committee appointment for Mary Treadway. Sharon Lee Wheeler, Granddaughter of Mary Treadway, was sworn in by Mr. Vickers and questioned by Mr. Blake, after which, there being no objection, Sharon Lee Wheeler was appointed Committee for Mary Treadway.

Carroll Miller, Gauley Bridge, came before the Commission requesting funds (\$20,000) for the Town of Gauley Bridge. After some discussion the Commission advised Mr. Miller they would take the request under consideration.

An order was entered this date by the Commission directing the County Clerk to prepare Certificate of Incorporation for the Town of Gauley Bridge.

Travis Harrington, Attorney, Fayetteville, appeared before the Commission concerning the appointment of three persons to serve as Commissioners for the election of Town Officials for Gauley Bridge. It was brought to the attention of the Commission the names of Ernest Hasenbalg, Giles Musick and Charles Bracken had been submitted by the anti-corporation group. Mr. Harrington submitted the names of Luther Toney, Ruby Winebrenner and Ina Hartman in favor of the corporation. After some discussion the Commission voted in favor of the following persons to serve as Commissioners: Luther Toney, Ruby Winebrenner and Ernest Hasenbalg. An order was entered this date appointing them as Commissioners, copy of which is attached.

Erwin Conrad appeared before the Commission in regard to Eastern Hardwoods request for approval of Industrial Bonds for purchasing and acquisition of real estate as heretofore discussed. Since Mr. Walter Wilson, Prosecuting Attorney, was out of town

and had not had an opportunity to review the documents it was the decision to table this matter until the next regular meeting, October 4, 1978 by which time Mr. Wilson would have reviewed the documents.

The County Commission watched the demonstration of the new equipment, JAWS, recently purchased by the Fayette County Firemen's Association.







Mr. Kermit Pomeroy appeared before the Commission concerning the County Commission helping sponsor the Meadow Creek Watershed Plan for flood control for the Town of Meadow Bridge and outlying area. He introduced Mr. Karl Williams, Soil Conservationist, Fayetteville, who presented some explanation and Mr. Williams then in turn introduced Mr. Terry Fairbanks from the Soil Conservation Office in Morgantown. He gave a detailed explanation of the plan and presented to each Commission member a Document Plan and also a computation sheet showing amount of cost for each sponsor, copies of which are hereto attached. After some discussion and questions Larry Bradford, Director, Region 4, Summersville, informed the Commission he was sitting in the meeting for the purpose of helping with a grant for local monies. It was brought out that the time table for the project would be about one or one and one-half years. Also attending the meeting were Bonnie Gwinn and six interested citizens of Meadow Bridge.

The Commission requested more information on the cost of project which will be presented at a later date.

Gary Harding, Zoning Officer, came before the Commission at the request of Pentree, Inc., for a change in land classification to permit the construction of a plastic plant. Mr. Lively made motion the request be granted as recommended by the Planning Commission, seconded by Dr. Stallard and passed by vote of 3 to 0.

Erwin Conrad appeared before the Commission concerning the Industrial Bonds for Eastern Hardwoods. After some discussion and consultation with Mr. Walter Wilson, Prosecuting Attorney, the Commission agreed to sign the Agreement and Resolution taking official action with respect to the proposed issuance of revenue bonds by the Fayette County Commission for Eastern Hardwoods.

Brentz Thompson came before the Commission concerning the committee appointment of Estella Smith. Also present was Attorney Steve Vickers and Gene Carte, Attorney, representing other relatives of the said Estella Smith. After some discussion it was brought out by Steve Vickers that his client has not been given sufficient notice and since the matter would have to be heard at another time it was decided by the Commission and all concerned to postpone this hearing until October 25, 1978 at 1:00 P.M.


It was recommended by the Fayette County Planning Commission that Norville Ellison of Mount Hope, whose term expires on December 20, 1978, be reappointed for another three year term.




